En la estrategia de internacionalización del centro, el programa Erasmus + desempeña un papel muy importante. De hecho, en el plan anterior (Plan Estratégico 2016-2020), el objetivo establecido por el centro en términos de internacionalización se basaba en la movilidad de los estudiantes en el Programa Erasmus +. El Plan Estratégico actual (2020-2023), además de ser más ambicioso, incluye entre sus objetivos prioritarios continuar con la movilidad de los estudiantes a través del Programa Erasmus +, ya que la visión de este programa se da desde el centro, lo que nos brinda una proyección internacional y moderna, además de una ventaja competitiva.

Bitoriano Gaudiaga Fundazioa pertenece a Heziketa Teknikoko Elkartea-HETEL el cual es miembro de EfVET, con la posibilidad de beneficiarse de los proyectos en los que HETEL participa como asociación. Nuestro centro participa en las movilidades Erasmus + que HETEL gestiona como consorcio, y nuestro personal docente tiene la oportunidad de visitar otras redes de centros europeos para conocer y llevar a los centros de la asociación las buenas prácticas observadas durante sus estancias. Todo esto nos ayuda a continuar entrenando y expandiendo nuestros planes de internacionalización y participación durante los próximos años.

El Departamento de Internacionalización ha tenido la figura de gerente de internacionalización desde el año académico 1998-1999, lo que garantiza el conocimiento y la experiencia en la gestión de becas. Para llevar a cabo la gestión de manera adecuada, este responsable participa periódicamente en las reuniones que se llevan a cabo para este fin en la asociación HETEL a la que pertenecemos.

Actualmente, Bitoriano Gaudiaga Fundazioa participa en movilidad Erasmus + para realizar prácticas en empresas. Bitoriano Gaudiaga Fundazioa, espera continuar participando en estos proyectos durante los próximos, aumentando si es posible el número de participantes cada año.

A continuación se explica cómo se ha implementado el Programa Erasmus + en cursos anteriores en términos del proceso de información, selección, preparación y seguimiento de estudiantes y acreditación (22 créditos).

La selección de los estudiantes que participan en el Programa Erasmus + se realiza a través del expediente académico, el nivel lingüístico y en función de las competencias transversales de los estudiantes que desean participar en él. Dada la variedad de ciclos de capacitación, se busca un equilibrio en el número de participantes en función del número de solicitudes. De esta manera, los únicos criterios que prevalecen en la selección de beneficiarios están regulados por los criterios exclusivamente citados, que se hacen públicos.

- El procedimiento para la selección de la movilidad de los estudiantes es el siguiente:

En el mes de octubre, el programa Erasmus + se presenta a los estudiantes de segundo año de formación profesional a través de una reunión. El programa Erasmus + se explica en la reunión, así como los criterios de selección para que los estudiantes sean beneficiarios de la beca de movilidad. Posteriormente, se abre un periodo para que todas las personas interesadas realicen la solicitud utilizando el formulario diseñado para tal fin.

- Los procedimientos de criterios de selección a aplicar son los siguientes:

El estudiante que no apruebe alguna materia del primer curso en el primer trimestre (antes de los exámenes de reparación) no será elegible para participar.

El puntaje final obtenido por cada candidato será la suma de los puntajes obtenidos en las siguientes secciones, hasta un máximo de 10 puntos:

1. 30%: expediente académico:

Calificación promedio de todos los módulos evaluados en la primera y segunda evaluación (hasta 3 puntos).

El director de la escuela del programa Erasmus + puede excluir a cualquier estudiante que no cumpla con sus compromisos en el proceso de admisión: entrega de documentación, asistencia a reuniones, ...

En cuanto a la participación de la movilidad del profesorado, la difusión de la movilidad se lleva a cabo y en función del objetivo a perseguir y las características de la movilidad, la selección se realiza entre los profesores candidatos. Se prioriza la igualdad de oportunidades teniendo en cuenta el historial de movilidad de cada uno de los docentes. Las diferentes posibilidades de movilidad provienen de la Asociación HETEL, por lo que no tienen una fecha fija establecida en el tiempo, que se repite en todos los cursos.

El centro y el profesor/a se comprometen a garantizar la calidad de la enseñanza dirigida a los alumn@s afectados por la movilidad que se realiza.

In the centre's internationalization strategy, the Erasmus + Program plays a very important role. In fact, in the previous plan (Strategic Plan 2016-2020) the objective set by the center in terms of internationalization was based on the mobility of students in the Erasmus + Program. The current Strategic Plan (2020-2023), in addition to being more ambitious, includes among its priority objectives to continue with student mobility through the Erasmus + Program, since the vision of this program is given from the center, giving us an international projection and modern, plus a competitive advantage.

Bitoriano Gandiaga Fundazioa belongs to Heziketa Teknikoko Elkarte-HETEL which is a member of Efvet, with the possibility of benefiting from the projects in which HETEL participates as an association. Our centre participates in the Erasmus+ mobilities that HETEL manages as a consortium, and our teaching staff has the opportunity to visit other European centre networks in order to get to know and bring to the centres of the association the good practices observed during their stays. All this helps us to continue training and expanding our plans for internationalization and participation during the coming years.

The Department of Internationalisation has had the figure of internationalisation manager since the 1998-1999 academic year, which guarantees knowledge and experience in the management of scholarships. In order to carry out the management in an adequate way, this responsible participates periodically in the meetings that are held for this purpose in the HETEL association to which we belong.

Currently, Bitoriano Gandiaga Fundazioa participates in Erasmus+ mobilities for internships in companies. Bitoriano Gandiaga Fundazioa, hopes to continue participating in these projects during the next ones, increasing if possible the number of participants each year

The following explains how the Erasmus + Program has been implemented in previous courses in terms of the process of information, selection, preparation, and monitoring of students and accreditation (22 credits).

The selection of the students participating in the Erasmus + Program is made through the academic record, linguistic level and based on the transversal competences of the students who want to participate in it. Given the variety of Training Cycles, a balance in the number of participants is sought based on the number of applications. In this way, the only criteria that prevail in the selection of beneficiaries are regulated by the exclusively cited criteria, which are made public.

- The procedure for the selection of student mobility is as follows:

In the month of October, the Erasmus + program is presented to the 2nd-year Professional Training students through a meeting. The Erasmus + program is explained at the meeting, as well as the selection criteria for the students to be beneficiaries of the mobility grant. Subsequently, a period is opened for all interested persons to make the request using the form designed for that purpose.

- The selection criteria procedure to be applied are as follows:

The student who fails any subject of the first course in the first trimester (before reparatory exams) will not be eligible to participate.

The final score obtained by each candidate will be the sum of the scores obtained in the following sections, up to a maximum of 10 points:

1. 30 %: academic record: Average rating of all the modules evaluated in the first and second evaluation (up to 3 points).

2. 30 %: level of verbal communication in the target language: This level will be evaluated by English teachers in an exam prepared for this purpose. (Up to 3 points)

3. 40 %: student qualification by tutors and teachers of their academic year taking into account: (up to 4 points)
- Responsibility and autonomy.
 - Motivation.
 - Ability to overcome problems.
 - Social skills.

The final score will be determined in the first meeting of the second evaluation. Once the selection is made, the results will be notified to the interested parties.

The head of the school of the Erasmus + program can exclude any student who does not fulfill their commitments in the admission process: delivery of documentation, attendance at meetings, ...

As for the participation of the mobility of the teaching staff, the dissemination of mobility is carried out and based on the objective to be pursued and characteristics of mobility, the selection is made among those candidate teachers. Equal opportunities are prioritized taking into account the mobility history of each of the teachers. The different possibilities of mobility come from the HETEL Association, so that they do not have a fixed date established in time, which is repeated in all courses.

The center and the teacher undertake to guarantee the quality of teaching aimed at the students affected by the mobility carried out.

1. Objetivos

Objetivo1: avanzar en un modelo de escuela más internacional

Avanzar en un modelo de escuela más internacional en términos de movilidad y acogida que permita, por un lado, aprender, compartir y aportar nuevas metodologías para mejorar las competencias de los estudiantes y, por otro lado, proporcionar a los estudiantes y profesores experiencias internacionales para mejorar sus competencias transversales y profesionales para trabajar en un mundo globalizado, que es una de las habilidades cada vez más demandadas.

Dentro de este objetivo, también marcamos la recepción de estudiantes y docentes de otros centros extranjeros con el objetivo de crear redes de cooperación que permitan, por un lado, aprender y compartir experiencias en la contribución de nuevas metodologías de aprendizaje y, por otro lado, para desarrollar proyectos conjuntos de mejora.

Desde 1998, Bitoriano Gandiaga Fundazioa ha participado en el proyecto europeo Leonardo y Erasmus Mobility para estudiantes y personal. También participamos en un proyecto que brinda asesoramiento técnico y capacitación de docentes en la escuela de formación profesional única en el Sahara, en los campos de la electricidad y la renovación de energías.

La recepción de estudiantes extranjeros ha sido irregular, por lo que ha habido años en los que los estudiantes han sido recibidos ininterrumpidamente, mientras que otros no, debido a circunstancias fuera del control de la escuela.

1. Objectives

Objective1: To advance in a more International School Model

To advance in a more international school model in terms of mobilities and welcome that allows, on the one hand, to learn, share and contribute new methodologies for the improvement of students' competences and, on the other hand, to provide students and teachers with international experiences to improve their transversal competences and professionals to work in a globalized world, which is one of the skills increasingly in demand.

Within this objective, we also mark the reception of students and teachers from other foreign centres with the aim of creating cooperation networks that allow, on the one hand, to learn and share experiences in the contribution of new learning methodologies and, on the other hand, to develop joint projects for improvement.

Since 1998, Bitoriano Gandiaga Fundazioa has taken part in Leonardo and Erasmus Mobility European project for students and staff. We also take part in a project providing technical advice and training of teachers in the unique vocational trainingschool in Sahara, in the fields of electricity and renewing energies.

The reception of foreign students has been irregular, so that there have been years in which students have been received uninterrupted, while others have not, due to circumstances beyond the school's control.

At the Bitoriano Gandiaga Fundazioa Foundation, the selection of the students participating in the Erasmus + Program is carried out under the principles of non-discrimination and transparency in all areas, in addition to guaranteeing full and equitable access to participants from all origins, paying special attention to the inclusion of those with fewer opportunities.

The selection of the students is carried out exclusively under the criteria of the academic record, linguistic level and based on the transversal competences of the students who want to participate in it (this has been explained in detail in section 1).

At the beginning of the course, a meeting is held with all the students of the 2nd Year Training Cycles, explaining the details of the Erasmus + Program and making the application sheet available to all interested parties to take part in mobility.

At the Bitoriano Gandiaga Fundazioa Foundation, we have an internal scholarship concession regime in place for all those families that are in a vulnerable situation for various reasons and have financial problems to meet the expenses derived from the education of their children. This aid granted by the Foundation aims to ensure that no person is excluded for financial reasons throughout the apprenticeship.
